Categories of Membership & Dues:

Full Membership: \$90.00 1st person in family; \$70.00 each additional.

Full membership includes USFS membership (commencing July 1st), subscription to Skating Magazine (1 per family), eligibility to represent SSFSC at qualifying and non-qualifying competitions and exhibitions, eligibility for SSFSC Board of Directors, "member" fees at SSFSC events. Parents are welcome and encouraged to join as well.

Introductory / Basic Skills Membership: \$60.00 for 1st person in family; \$60.00 each additional.

Introductory members are individuals who have never been a full member or individual member of U.S. Figure Skating who may join only as members of a member club. They will receive a special discounted membership rate for one year only, and will be accorded all the benefits and privileges of full membership. No person can be an introductory member for more than one year, even if their membership lapses. Ideal for skaters new to testing, as well as skaters in the Snowplow and Basic 1 – 8 levels. Membership includes USFS membership (commencing July 1st), subscription to Skating Magazine (1 per family), eligibility to represent SSFSC at competitions and exhibitions and "member" fees at SSFSC events such as SSFSC freestyle sessions, classes and test sessions.

Associate Membership: \$70.00 1st person in family; \$60.00 each additional.

Anyone seeking Associate membership must be a full member of another club. USFS membership not included. Associate Membership includes "discounted" fees at SSFSC events.

Collegiate Membership: \$100.00

This is a four-year full membership (commencing July 1st) for college-aged members and all skating privileges apply for the four-year duration. Each athlete may receive this option only once during their entire skating career. This membership includes the same privileges as a full member, including subscription to SKATING magazine, all testing and competition rights as well as eligibility for SSFSC Board of Directors and "member" fees at SSFSC events.

Friend of SSFSC Membership: \$60.00 minimum donation

For non-skating adults who wish to support the club. Friends of SSFSC includes USFS membership, eligibility for SSFSC Board of Directors as well as opportunities to volunteer.
